


Thank you to everyone who completed MNORN's survey on topics you would like ANA to discuss at the Membership Assembly this June. The MNORN Board discussed the results of the survey at their meeting earlier this month, considering carefully all of the topics. In addition, they considered the requirements ANA has required for submission. These requirements include whether it fits with ANA's mission and strategic initiatives; if there is already a policy; if there is already ongoing work, and if it has national impact. Based on your input and ANA's requirements, the MNORN Board selected the following two topics:

- To update the 2008 ANA House Resolution on Global Climate Change to reflect new knowledge since its passage ten years ago.
- To develop policies that effectively address nursing's role in providing evidence based, compassionate care to migrants, refugees and displaced persons (MRDPs)

Q1 What broad topics would you be most interested in having ANA discuss at Membership Assembly?









Q5 What topics would you be most interested in being included in Climate Change?





Q6 What topics would you be most interested in being included in Substance Use Disorder among nurses?





Q7 What topics would you be most interested in being included in Immigration?





Q8 What topics would you be most interested in being included in Legislative and Regulatory Issues?







STATEMENT FROM ANA ABOUT The VANDERBILT NURSE INCIDENT

Silver Spring, **MD** - A former Vanderbilt University Medical Center nurse is scheduled to appear in court today for reckless homicide and impaired adult abuse charges after mistakenly administering the wrong medication that killed an elderly patient in 2017. The American Nurses Association (ANA) extends its sincerest condolences to the family of the patient who died and to all those who are suffering because of this event.

ANA supports a full and confidential peer review process in which medical errors can be examined and system improvements and corrective action plans can be established to ensure that errors such as this do not occur in the future. Swift and appropriate action should and must always be taken when medical errors occur.

Health care is highly complex and ever-changing resulting in a high risk and error-prone system. However, the criminalization of medical errors could have a chilling effect on reporting and process improvement. The Code of Ethics for Nurses states that while ensuring that nurses are held accountable for individual practice, errors should be corrected or remediated, and disciplinary action taken only if warranted. When error occurs, whether it is one's own or that of a coworker, nurses may neither participate in, nor condone through silence, any attempts to conceal the error.

ANA acknowledges that the full facts and circumstances of this incident are still developing. This tragic incident should serve as reminder to all nurses, other health care professionals, and administrators that we must be constantly vigilant at the patient and system level. ANA stands ready in support of patients, nurses, and other healthcare providers in achieving high reliability in organizations to prevent these types of incidents from reoccurring.

ANHE Environmental Health Nurse Fellowship Fellows Information and Application

The Alliance of Nurses for Healthy Environments' (ANHE) Environmental Health Nurse Fellowship is designed to increase the capacity of nurses to address environmental and health equity issues in collaboration with communities, agencies, and public health and nursing organizations. The Fellowship will have a particular emphasis on climate change and health equity, but will include content on a variety of environmental health topics such as chemical exposures; food, air, and water quality; energy and health; and environmental justice. Environmental justice, the notion that no community should be disproportionately impacted by environmental exposures is a core value of ANHE in all of our work.

This new Fellowship program is being offered to increase nurses' capacity to assess and address environmental health issues, with a focus on community-level impact and solutions to advance health equity for those disproportionately affected by environmental hazards. The Fellowship is a year-long program including environmental health education to gain a more thorough understanding of how environmental risks impact human health, as well as advocacy and community organizing, engagement, and empowerment basics. Fellows will be assigned a mentor and both the fellows and mentors will be funded to attend two national Fellowship meetings.

Program Requirements

Three fellows will be selected from each of the 10 U.S. Environmental Protection Agency (EPA) regions (https://bit.ly/2SzLe6C) for a total of 30 nurses. Each fellow will be paired with a nurse mentor with significant experience in environmental health and community partnerships. Together, the mentor and fellow will identify a target community and develop a plan to guide the Fellowship experience. Fellowship participants will enhance their knowledge and build a breadth of experience. Program requirements for fellows include:

- Commit to year-long participation in the fellowship program (June 1st, 2019- May 31st, 2020)
- Attend monthly webinars (2 hours/month)
- Communicate with mentors at least on a monthly basis (1-2 hour/month)
- Develop a project that addresses an identified community need in partnership with a community-based organization (a local school, faith-based organization, civic organization, non-profit association [including environmental organization], community-engagement programs of hospitals/health systems, etc.)
- Hold three educational sessions for health professional colleagues on environmental health that includes work conducted during the program
- Provide quarterly reports to mentor and program staff on project and Fellowship progress
- Attend two 2-day, in-person national Fellowship meetings throughout the program period (June 3rd-5th 2019 in Philadelphia, PA and March 2020 location TBD). Note: The cost of travel and lodging will be covered by ΔNHF

Through participating in the program, fellows will receive at a minimum 36 hours of nursing continuing education hours and demonstrate learning through a community-based project addressing a specific environmental health concern. Time commitment is estimated at 12-15 hours per month.
