

Results from the polling question during the 2022 **MNORN** election and SurveyMonkey




# Q2 What topics would you be most interested in being included in APRN issues?


# Q3 What topics would you be most interested in being included in Ethics?

- Communicating Code of Ethics to nurses in practice


# Q4 What topics would you be most interested in being included in Healthcare Reform?




# Q6 What topics would you be most interested in being included in Mental Health for Nurses?

## Q7 What topics would you be most interested in being included in Nursing Education?






# Q9 What topics would you be most interested in being included in Nurse Staffing?




## Q11 What topics would you be most interested in being included in Planetary Health?




# Q13 What topics would you be most interested in being included in Professional Nursing Organizational issues?






## Q16 What topics would you be most interested in being included in Reproductive Rights?

- Increasing maternity leaves to a minimum of 6 months



# For My Krystee, aka Crystal

The day after Christmas I received a call that my best friend passed away unexpectedly. My best friend was one of the best nurses I have ever met, and she battled alcoholism for the last decade. I met Crystal late in undergrad nursing school and our friendship bonded quickly as we oriented together on the same unit which was our shared dream job. We had all our "firsts", the ups and the downs, as new nurses together. We made the best of our young adult lives as single ladies because we had each other's company, but as we grew into adulthood the stresses of life led Crystal to reach for alcohol.

If you know me well you know I can sometimes be called Kath or Kathy, and I hate it every time. That name was given to me by Crystal. During our nursing orientation I waited in the pickup line after ordering my lunch at the café across the hospital on 16<sup>th</sup> and Capitol far longer than anyone else in our lunch group. After several minutes passed, I was getting angrier, and my lunch hour was ticking away, Crystal giggled and said, "Hey Kath, I think you lunch

has been ready." Crystal had noticed that the server had been calling for Kathy because my name tag used to say Katherine. Ever since then she roused all my friends and coworkers to call me Kathy and my family still uses it to this day. I want to hear my friend and one of the best nurses I know, Crystal, call me Kath again.

Crystal suffered from mental illness, bouts of anxiety and depression, as many of us have and will have during our career as nurses. My friend and I exchanged many stories of our struggles with early adulthood and the hurdles of our early careers. Over time Crystal began suffering from a quiet addiction. After facing over a decade of alcoholism, she never said to me things like "I am an alcoholic" or "I am struggling and need help". She put on a show and kept her secrets until a few years ago she was escorted off her unit, drug screened, and her license was emergently suspended. I was in complete shock. That's not the Crystal I know. As result of the continued multiplying stressors of life, magnified by the effects of her disease, she continued to lean deeper into her crutch, silently and behind closed doors. This "best nurse I know" was non-compliant in her treatment plans and refused multiple forms of help from those that loved her the most. While giving her heart and soul to the sickest of pediatric patients remained her passion, she was never able to return to nursing. Crystal lost her battle with alcoholism as quietly as it started.

Silence in fallibility cannot be tolerated in our profession. Nurses, while we may seem invincible, carrying the weight of the world and our patients on our shoulders, we are still human. We too carry burdens of debt, struggling relationships, loss, and poor health. We too suffer from mental illness. As nurses we must recognize and accept our own vulnerability, and that of our colleagues. We do not need to prove our stoicism. We must not tolerate pride in invincibility and silence. We are all human beings, not superhuman. By showing compassion to our own self, and to our colleagues, we in turn ripple compassion through the care we provide to our patients.

Alcoholism affects more than just the person carrying the disease. My friend's struggle with alcohol also affected me, our families, and our friends. As Crystal's best friend, I have carried blame and guilt, and her recent death has left a hole in my heart. I have suffered the loss of my best friend slowly for the past decade and now I am suffering her loss all over again. We can no longer be silent about alcoholism and mental illness within our profession.

Alcoholism, a progressive illness, cannot be fixed by mere willpower, a change of scenery, more rest or changing hobbies. The sufferer has lost the power of

choice over alcohol. It is a disease that cannot be cured but can be halted. Shared by Alcoholics Anonymous, it is most important to face the facts of one's illness and to take advantage of help that is available.

I have connected with my longstanding therapist and will continue to seek resources and increase self- compassion to process this tragedy. I will not carry this burden alone and I will not stay silent about addressing addiction and mental illness in nursing.

I ask you to take pause with me and ask yourself how are YOU doing right now? Have you taken time to give yourself compassion for the work you do and for your complex and stressful life beyond your service? Are the crutches you have chosen sustainable, healthy? Without a doubt many of us will breeze by these questions. Stop the stoicism. Reread and answer yourself truthfully.

I ask that you reach out to your nursing friends and colleagues. Check in on one another. Search for honesty and address harmful crutches. Share resources. Encourage seeking care and assistance.

In memory of Crystal (Goens) Lawson, I ask you to keep the nurses lamp lit by caring for your own flame. Without each other, we have nothing.

# Nursing Research Day 2023:Addressing Health Disparities and Promoting Social Justice through Nursing Research

Friday, April 14, 2023: 8:30 am to 3:30 pm

The University of Minnesota's School of Nursing will be hosting the 2023 Nursing Research Day conference on Friday, April 14. This year's theme is Addressing Health Disparities and Promoting Social Justice through Nursing Research. The event is free; ANCC credit will be offered. Throughout the day, faculty, community partners and students will lead concurrent podium and poster presentation sessions that showcase findings from innovative research and evidence-based projects that improve health and quality care.



**Our keynote speaker** is Bridgette M. (Brawner) Rice, PhD, MDiv, APRN, FAAN. Dr. Rice is the Richard and Marianne Kreider Endowed Professor in Nursing for Vulnerable Populations in the M. Louise Fitzpatrick College of Nursing at Villanova University. She holds degrees from Villanova University (BSN '03), the University of Pennsylvania (MSN '05, PhD '09) and Palmer Theological Seminary of Eastern University (MDiv 17).

Dr. Rice began her nursing career in neonatal intensive care at the Children's Hospital of Philadelphia. She has since expanded her work to community-based practice. Her methodological advances have been applied to address multiple health inequities (e.g., youth mental health service utilization, cardiovascular disease risk among young Black men, gun violence) where she uses novel approaches including mixed methods research and GIS mapping. Cognizant of the role of geography in health, her spatially-based research explicates and intervenes in factors such as neighborhood disadvantage to prevent disease and promote health equity. Dr. Rice is a staunch justice advocate who believes that research can be leveraged as an advocacy tool to ensure all individuals have an opportunity to achieve their full health potential. Her work has been featured through multiple media outlets, and she has received numerous honors and awards, including the Friends of the National Institute of Nursing Research Protégée Award in 2015 and the International Society of Psychiatric Nurses Diversity and Equity Award in 2020.
